

Purina For Life* Sweepstakes
Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The “Purina for Life” Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Nestlé Purina® PetCare Company, Catalina Marketing Corporation, Vericast Corp., Merkle Inc., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules. Sponsor’s and Administrator’s decisions are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Timing: The Sweepstakes begins on June 1, 2022 at 12:00 a.m. Eastern Time ("ET") and ends on July 31, 2022 at 11:59 p.m. ET (the "Promotion Period"), and consists of eight (8) Weekly Entry Periods as well as one Grand Prize Entry Period equal to the Promotion Period (each an “Entry Period”) as set forth in the table below,

Sponsor’s servers are the official time-keeping devices for the Sweepstakes.

4. How to Enter: There are two (2) ways to enter.

a. Purchase Qualifying Purina Puppy or Kitten Food:

- i. **Register:** Visit purinaforlife.com (“Promotion Website”) and follow the links and instructions to complete the registration form including providing your first name, last name, zip code and email address. Select whether you would like to be entered for the cat or the dog prize (“Weekly Prize Type”) for all of the Weekly Entry Period drawing(s) during the Promotion Period. You will be required to provide name, breed size (puppy only) and birthdate for your puppy or kitten. *You also will be given an opportunity to opt-into future marketing emails from Sponsor. You do*

not have to opt-in to future marketing emails to enter the Sweepstakes and opting-into future marketing emails will not improve your chance of winning a prize.

ii. During the Promotion Period, Purchase a “Qualified Product” & Upload Receipt:

(a) Make an in-store or online purchase of a 3 pound or larger bag of Beneful, Purina Puppy Chow, Purina ONE or Purina Pro Plan dry puppy food and/or a 3 pound or larger bag of Beyond, Purina Kitten Chow, Purina ONE or Purina Pro Plan dry kitten food as listed in the attached Appendix (herein a “Qualifying Product”). Be sure to keep your receipt.

(b) Take an image of your entire purchase transaction receipt. The receipt image must be clear and legible, and display all of the following: the retailer name, the purchase date and time, the Qualifying Product, the price of the Qualifying Product and total amount spent (collectively, herein a “Qualifying Receipt”). Qualifying Receipt image must not be larger than 5MB and may only be one of the following file types: .gif, .png, .jpg, or .pdf.

(c) Follow the links and instructions to upload your receipt image. Each receipt can only be uploaded once. For each Qualified Purchase included in your receipt, you will receive one (1) Weekly entry for the Prize Type you have selected and one (1) Grand Prize entry, up to the Weekly Entry Limit set forth below.

iii. Earn Bonus Entries by Sharing the Program When Your Friends Enter: After you upload a receipt, you will be invited to share a unique link with your “Friends” by Twitter. Friends must be persons with whom you have a personal relationship who meet the eligibility requirements outlined in Section 1. You will be able to share your unique link by Tweet once (1) each Weekly Entry Period.

You will receive one (1) Bonus Entry for the applicable Weekly Entry Period drawing and one (1) Bonus Entry for the Grand Prize drawing for each Friend who uses your unique link to register and upload a Qualified Receipt. Limit: You can receive up to five (5) Bonus Entries from Friends who you referred through Twitter.

iv. You may return to Promotion Website and sign in to your account to submit additional receipts (up to four (4) Qualified Products each Weekly Entry Period) to receive additional entries into Weekly Entry Period drawings and the Grand Prize drawing throughout the Promotion Period.

b. Mail-in Free Method: To enter without purchase or referral of Friends, print your name, home mailing address, phone number, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to “Purina For Life,” c/o Merkle Inc., P.O. Box 5022, Department 852285, Kalamazoo, MI 49003-5022. You must include the Weekly Entry Period (i.e., Week 1, Week 2) and Weekly Prize Type (i.e., Cat or Dog) on the front of the envelope for which you would like an entry. You will receive one (1) entry into the listed Weekly Entry Period for your selected Prize Type as well as one (1) entry into the Grand Prize Entry Period. Limit: One (1) mail-in request per envelope; up to nine (9) mail-in requests each Weekly Entry Period. All mail-in requests must be postmarked as indicated in the chart in Section 3 and received no later than August 8, 2022. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: You may receive up to nine (9) entries each Weekly Entry Period by any combination of entry methods. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned

an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

5. Prize Drawings: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. On or around the dates set forth in the table in Section 3, Administrator will randomly select the potential Weekly Entry Period winners from all eligible entries received during the applicable Weekly Entry Period for each Weekly Prize Type. Non-winning entries will not be included in subsequent Weekly Entry Period drawings. Administrator will randomly select the potential Grand Prize winner from all eligible entries received during the Promotion Period. Potential winners will be notified by email from Administrator and must take the following steps:

- a. **Potential Weekly Entry Period Prize Winners** may be required to provide their name, home mailing address (P.O. Boxes not permitted) and date of birth to confirm eligibility and for prize fulfillment purposes within three (3) days of the date notice or attempted notice is sent into order to claim the prize.
- b. **Potential Grand Prize Winner** (or parent/legal guardian if winner is a minor in his/her state of residence) will be required to sign and return a Declaration of Compliance, Liability Waiver and where not prohibited a Publicity Release ("Declaration") which must be received by Administrator within five (5) days of the date notice or attempted notice is sent, in order to claim the Grand Prize.

If a potential winner of any prize cannot be contacted, fails to sign and return the Declaration, fails to provide information to confirm eligibility or to provide any other requested information within the required time period (as applicable), or the prize is returned as undeliverable, the potential winner forfeits the prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason or forfeits the prize, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded.

6. Prizes: ONE (1) GRAND PRIZE: "Purina For Life," fulfilled as a check for \$22,500.

The Purina For Life Grand Prize was calculated using the estimated high end of the lifespan of a pet (17 years for dog, 20 years for cat) and based on veterinarian recommendations to feed puppy food for approximately two years and kitten food for approximately one. Sponsor's nutritionists estimated that an average size pet (35 pounds for a dog, 10 pounds for cat) would consume the following amount of food per year:

- Dog: 200 pounds/Puppy: 150 pounds
- Cat: 65 pounds/Kitten: 50 pounds

Sponsor multiplied those consumption amounts by the highest priced Purina dry pet food for each pet in terms of dollars per pound to come up with the annual total cost of food per pet. From there Sponsor factored in an inflation rate of 3.5% annually to determine the lifetime spend on both cat and dog. Sponsor used the higher dollar amount (dog) to come to the Grand Prize amount of \$22,500 (rounded up). Approximate Retail Value ("ARV"): \$22,500.

WEEK ONE PRIZES:

- Fifty (50) Dog Prize Type Prizes ("Dog Prizes"): \$50 Prepaid Reward, fulfilled digitally. Your use of the prepaid reward is governed by the Cardholder Agreement, and some fees may apply. - Thirty (30) Cat Prizes: One (1) \$75 Amazon.com Gift Card, fulfilled as a digital code. ARV: \$75

- One-Hundred (100) Dog Prizes: One (1) dog imprinted 50" x 60" woven blanket, fulfilled by mail. ARV: \$25.
- One-Hundred (100) Cat Prizes: One (1) cat imprinted 50" x 60" woven blanket, fulfilled by mail. ARV: \$25.

For all Prizes: Terms and conditions of all gift cards apply. Winners should address issues regarding any gift code prizes directly with retailer. Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance and may modify the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Michigan without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
